

**Avocados from Mexico® Guac Drops and Guac Box Suite Sweepstakes
Official Rules**

1. **ELIGIBILITY:** The Avocados from Mexico® Guac Drops and Guac Box Suite Sweepstakes (the “Sweepstakes”) is open only to legal residents of the fifty (50) United States and the District of Columbia who are the age of majority in their state of residence as of the time/date of entry. Employees, officers and directors of Avocados From Mexico, Inc. (“Sponsor”), which is a non-profit subsidiary of the Mexican Hass Avocado Importers Association (“MHAIA”), Realtime Media LLC (“Administrator”), and their respective parent companies, affiliates, subsidiaries, advertising, contest, fulfillment and marketing agencies (collectively, the “Sweepstakes Parties”), their immediate family members and those living in the same household as such individuals (whether legally related or not) are not eligible to participate in the Sweepstakes or win a prize. For purposes of this Sweepstakes, immediate family members are defined as spouse, partner, parents, legal guardians, in-laws, grandparents, siblings, children and grandchildren and their respective spouses, and those living in the same household shall mean people who share the same residence at least three (3) months a year, whether legally related or not. Void where prohibited by law. All federal, state, and local laws and regulations apply. By participating in the Sweepstakes, you unconditionally accept and agree to comply with and abide by these Official Rules and the decisions of Sponsor, including the interpretation of these Official Rules, administration of the Sweepstakes, selection of the winners, and Sponsor’s exercise of discretion, which will be final, non-appealable, and binding in all respects.
2. **TIMING:** The Sweepstakes begins at or about 8:00 a.m. Central Time (“CT”) on September 19, 2026 and ends at 11:59 p.m. CT on December 4, 2026 (the “Sweepstakes Period” and “Grand Prize Entry Period”). The Sweepstakes also consists of eleven (11) weekly entry periods (each, a “Weekly Entry Period”), as set forth in the chart below:

3. **HOW TO ENTER:** During the Sweepstakes Period, there are two (2) ways to enter the Sweepstakes, as described below:

a) Website Entry: During the Sweepstakes Period, visit www.avocadosfrommexico.com/college-football ("Website") and complete and submit an official entry form with all required information. Upon successful submission of the entry form, you will receive one (1) entry into the Grand Prize drawing (a "Website Entry"). **Website Entries are eligible for the Grand Prize drawing only and are not eligible for any Weekly Prize drawing.**

b) Instagram Entry: During each Weekly Entry Period, locate the applicable Sweepstakes post ("Post") on the @AvocadosFromMexico Instagram account and follow the instructions in the Post, including commenting on the Post and tagging a friend. Upon completing the required steps, you will receive one (1) entry into the applicable Weekly Prize drawing and one (1) entry into the Grand Prize drawing (an "Instagram Entry").

Bonus Entry: During an applicable Weekly Entry Period, you may receive one (1) additional entry by sharing/reposting the applicable Post to your Instagram Story, including #Sweepstakes, and tagging @AvocadosFromMexico (a "Bonus Entry"). Your Instagram Story must be visible and verifiable by Sponsor and/or Administrator during the applicable Weekly Entry Period to receive the Bonus Entry.

Website Entries, Instagram Entries and Bonus Entries may be referred to collectively herein as "Entries" and each individually as an "Entry."

The Sweepstakes Parties are not responsible for technical difficulties of any kind, or for false, incorrect, changed, incomplete or illegible contact information.

LIMIT: There is no limit to the number of Entries an entrant may receive during a Weekly Entry Period or into the Grand Prize drawing, subject to the entry requirements set forth above. follow all instructions, provide the required information, or abide by these Official Rules or other instructions of Sponsor may be disqualified. Entries submitted by those who do not meet the eligibility requirements (including all requirements with respect to age and residence) are void.

In the event of a dispute over the identity of an entrant, an Entry will be deemed submitted by the registered account holder of the email address or Instagram account, as applicable, associated with such Entry, provided that person is eligible. Any potential winner may be required to show proof of being the registered account holder. For purposes of a Website Entry, the registered account holder is defined as the person assigned to the applicable email address by an Internet access provider, online service provider, or other organization responsible for assigning email addresses. For purposes of an Instagram Entry or Bonus Entry, the registered account holder is the person assigned to the applicable Instagram account. In the event that a dispute regarding the identity of the individual who submitted an Entry cannot be resolved to Sponsor's satisfaction, the affected Entry will be deemed ineligible.

4. **SWEEPSTAKES DRAWING:** On or about the applicable drawing dates set forth in the chart above, the Administrator will conduct a separate random drawing from among all eligible Entries received during the applicable Weekly Entry Period to select the applicable potential Weekly Prize winners. Entries received during one Weekly Entry Period will not carry forward into subsequent Weekly Prize drawings. Following the conclusion of the Sweepstakes Period, the Administrator will conduct a random drawing from among all eligible Entries into the Grand Prize drawing received in accordance with these Official Rules to select two (2) potential Grand Prize winners.
5. **ODDS:** Odds of winning a Weekly Prize depend on the total number of eligible Entries received during the applicable Weekly Entry Period. Odds of winning a Grand Prize depend on the total number of eligible Entries received during the Grand Prize Entry Period.
6. **WINNER NOTIFICATION/PRIZE CLAIMING:** Each potential winner will be notified via email, Instagram direct message, and/or other contact information available to Sponsor or Administrator in a commercially reasonable time after the applicable drawing. The Sweepstakes Parties are not responsible for and shall not be liable for incorrect, changed, or illegible contact information or for electronic communications that are undeliverable as a result of any form of active or passive filtering, or insufficient space in entrant's email or other account to receive messages. Sweepstakes Parties are not responsible for late, lost, intercepted, misdirected, or unsuccessful efforts to notify the potential winner. Notification is deemed to have occurred immediately upon the sending of an email or other electronic communication. As part of the winner notification process, each potential winner will be required to complete and submit a prize redemption form ("Redemption Form"), including the potential winner's name, address, email address, and birthdate, within two (2) days of Sponsor's date of notification, as a condition of receiving a prize. Each potential Grand Prize winner will also be required to complete and return a Declaration of Eligibility/Liability & Publicity Release (where permitted by law) ("Declaration") within five (5) days of the date of notification.

Two (2) Grand Prizes: Each Grand Prize is a trip for the winner and one (1) guest to Las Vegas, Nevada, in connection with the 2027 College Football Playoff National Championship on January 25, 2027. Each Grand Prize includes round-trip coach-class airfare for the winner and one (1) guest; two (2) nights' hotel accommodations in one (1) double-occupancy standard room; round-trip ground transportation between the airport and hotel and between the hotel and event; and admission for the

winner and guest to the Guac Box suite at the Championship Game. The ARV of each Grand Prize is \$30,000.

The total ARV of all prizes available in the Sweepstakes is \$125,063.

Grand Prize Travel Conditions: Grand Prize travel is currently anticipated to take place on or about January 24–26, 2027, and the Championship Game is currently scheduled to take place on January 25, 2027. Exact travel dates and arrangements are subject to availability and change. Prizes are awarded "AS IS" and without warranty of any kind, express or implied (including, without limitation, any implied warranty of merchantability or fitness for a particular purpose). Winners will be solely responsible for all federal, state and/or local taxes, and for any other fees or costs associated with a prize received, regardless of whether it, in whole or in part, is used. The ARV of a prize is based on available information provided to Sponsor as of the time these Official Rules are printed and may fluctuate. Unclaimed prizes will be forfeited. Prizes, if legitimately claimed, will be awarded. The Sweepstakes Parties are not responsible for and will not replace any lost, mutilated or stolen prize or any prize that is undeliverable or does not reach a winner.

The Sweepstakes Parties do not assume any responsibility for any disruption in the Sweepstakes, including, but not limited to, the failure or interruption of any social media platform or any internet service provider. GOVERNING LAW AND LIMITATION OF LIABILITY: All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules or the rights and obligations of entrants, Sponsor or the Released Parties in connection with the Sweepstakes will be governed by and construed in accordance with the internal laws of the State of Texas, without giving effect to any choice of law or conflict of law rules or provisions that would cause the application of any other laws.
